CURRENTLY THERE ARE 11 INMATES READY TO GO TO DOC. 6 INMATES WERE TRANSFERRED TO THE OKLAHOMA DEPARTMENT OF CORRECTIONS THIS WEEK. TODAY'S COUNT IS 371 INMATES

MICHAEL MERRITT, EMERGENCY MANAGEMENT DIRECTOR GAVE HIS WEEKLY REPORT. THERE WERE 14 CONTROL BURNS, 36 EMRS, 5 OUTSIDE FIRES, 4 STRUCTURE FIRES, 1 AUTOMATIC ALARM, 2 SERVICE CALLS, 1 VEHICLE FIRE AND 1 NATURAL GAS LEAK.
