**RESOLUTION CLOSING COMANCHE COUNTY COURTHOUSE TO THE PUBLIC  
DUE TO CO-VID 19 PANDEMIC AND NEED FOR SOCIAL DISTANCING PER CENTER FOR DISEASE  
CONTROL (CDC) GUIDELINES AND THE STATE OF OKLAHOMA DECLARING A STATE OF EMERGENCY.**

**WHEREAS**, the Board of County Commissioners for Comanche County, Oklahoma, on this date signed below, passed a resolution declaring a State of Emergency in Comanche County because of the widespread threat of the COVID-19 pandemic.

**WHEREAS**, as of the passing of this Resolution, the CDC recommends extreme efforts for social distancing and the State of Oklahoma has declared a State of Emergency.

**WHEREAS**, in order to protect the health and safety of county employees and the citizens of Comanche County, the Board of County Commissioner believe that closing the Comanche County Courthouse to the public is necessary and that the closure of restaurants/bars/taverns located in the county is necessary.

**WHEREAS**, in order to protect the health and safety of the citizens of Comanche County, the Board of County Commissioners instructs individuals with court proceedings to contact the assigned judge for additional information on court hearings.

**NOW THEREFORE, BE IT HEREBY RESOLVED**, in open meeting that the Board of County Commissioner for Comanche County, Oklahoma hereby resolves that the Comanche County Courthouse will be closed to the public until further notice of said Board, and that any individual with a court proceeding contact the assigned judge for additional information on court hearings.

**NOW THEREFORE, BE IT HEREBY RESOLVED**, in open meeting that the Board of County Commissioner for Comanche County, Oklahoma hereby resolves that the restaurants/bars/taverns located in the county be closed to the public effective 5:00 p.m. March 23, 2020 and until further notice of said Board. To-go/curbside orders are permissible during these closures.

**COMANCHE COUNTY DISASTER EMERGENCY PROCLAMATION**

WHEREAS, March 23, 2020, a CO-VID 19 virus pandemic, having occurred in Comanche County, Oklahoma, causing zero (0) known fatalities and unknown injuries in Comanche County, Oklahoma, with considerable damage to public and private properties; and

WHEREAS, immediate attention is required to protect the public health, reduce further damage, provide public safety, and render emergency relief; and

WHEREAS, the Board of County Commissioners for Comanche County, Oklahoma, do find that the aforementioned conditions constitute a threat to the safety and welfare of the county and create an emergency disaster situation within the meaning of Title 63 Oklahoma Statutes Section 683.1 et seq. of the Oklahoma Emergency Management Act of 2003.

NOW THEREFORE, the Board of County Commissioners for Comanche County, Oklahoma, do hereby declare Comanche County to be an emergency area due to the significant events from the CO-VID 19 virus pandemic, and Comanche County is entitled to aid, relief, and assistance and do hereby direct the implementation of the County Emergency Operations Plan as adopted and amended by the State of Oklahoma.

NOW THEREFORE, this Proclamation shall be perpetual from the date below until further action of the Board of County Commissioners for Comanche County, Oklahoma.
